1. On or about February 20, 2008, Milford filed the Application along with ten Exhibits to the Application. The Application is currently pending and scheduled for hearing on May 28, 2008.

2. By a letter dated March 11, 2008, the Operating Agent for the Department of Water and Power of the City of Los Angeles (“LADWP”) requested that the Intermountain Power Authority (“IPA”) approve and authorize IPA’s entering into a Large Generator

Interconnection Agreement (“Interconnection Agreement”) with Milford Wind Corridor Phase I, LLC.

3. By a Resolution of the Intermountain Power Project Coordinating Committee, dated as of March 31, 2008, said Coordinating Committee approved the Interconnection Agreement.

4. On or about May 8, 2008, the Board of Directors of Intermountain Power Agency, by a Resolution dated as of March 31, 2008, approved the Interconnection Agreement.

5. Milford hereby submits as Exhibit 11 to the Application the following documents and requests that they, along with the Exhibits 1-10, be made part of the record herein: (1) a copy of the letter from LADWP to IPA, dated March 11, 2008, requesting approval of the Interconnection Agreement; (2); a copy of the Resolution of the Intermountain Power Project Coordinating Committee approving the Interconnection Agreement, dated as of March 31, 2008; and (3) a copy of the Resolution of IPA approving the Interconnection Agreement, dated as of March 31, 2008.
