On December 10, 2021, Rocky Mountain Power (RMP) filed an Application to Establish an Interim Rate Process in the Energy Balancing Account (“Application”). On December 17, 2021, the Public Service Commission (PSC) issued a Notice of Filing and Comment Period, inviting comments on RMP’s Application by January 18, 2022, and reply comments by February 2, 2022. On January 19, 2022, the Division of Public Utilities (DPU) filed a request for an extension of the comment deadline to no later than January 20, 2022, noting it was in the process of determining and requesting additional information from RMP to complete its review. To afford all interested persons additional time to submit comments in this docket, we amend the comment period as follows: Any interested person may submit comments on RMP’s Application on or before **Thursday, January 20, 2022**, and reply comments on or before **Friday, February 4, 2022**.
