The Utah Office of Consumer Services moves the Commission to amend the August 4, 2009 Scheduling Order as follows:

The deadline for parties other than Rocky Mountain Power to file direct testimony on Phase 1 issues to be amended to November 12, 2009 (now scheduled for October 29, 2009).

The deadline for parties to file rebuttal testimony to direct testimony due on November 12, 2009 to be amended to Monday, December 10, 2009 (now scheduled for November 24, 2009).

The deadline for parties to file sur-rebuttal testimony to rebuttal testimony due on December 10, 2009 to be amended to Tuesday, January 5, 2010 (now scheduled for December 8, 2009).

The time for responses to discovery should be adjusted accordingly. The Office does not propose other changes to the schedule.

At the July 14, 2009 scheduling conference, the testimony due dates were determined using the December 16 and 17, 2009 hearing as the point of reference. At the conference, the Office expressed its opinion that the time to review testimony and prepare responsive testimony was unusually compressed. The Commission's order scheduling hearings for January 11 to 14, 2010 allows for a schedule that is more typical and accommodates the parties' workload from other dockets.
