**Response to Utah Office of Consumer Services' Motion to Amend August 4th
Scheduling Order by Salt Lake Community Action Program**

Salt Lake Community Action Program (SLCAP) is supportive of the concept of the motion of the Utah Office of Consumer Services to amend the August 4th Scheduling Order to allow parties more time to review testimony and file responsive testimony in light of the later dates for hearings scheduled in the Order.

However, SLCAP notes that some of the dates proposed by the Utah Office of Consumer Services are the same as filing dates in the Rocky Mountain Power General Rate Case and would respectfully request that the Commission consider modifying the proposed dates in order to stagger the filings.

The proposed dates that are identical to those in the General Rate Case are as follows:

The November 12th deadline for parties other than Rocky Mountain Power to file direct testimony on Phase I issues (could be rescheduled for November 16th); and

The January 5th, 2010 deadline for parties to file sur-rebuttal testimony (could be rescheduled for January 6th unless the Rate Design portion of the case is vacated and the conflict with this date becomes moot).

SLCAP appreciates the consideration of the Public Service Commission in this matter to better accommodate the workload of the parties in the various dockets.
