Parties shall file testimony with the Commission in accordance with the foregoing schedule and shall follow the procedures set forth at "PSC Filing Requirements" under the "MISC." tab on the Utah Public Service Commission website homepage. Additionally, written testimony and other exhibits offered into evidence shall conform to Utah Administrative Code R746-100-10.F.2. In particular, they shall adequately explain: "Explicit and detailed sources of the information contained in the exhibit; methods used in statistical compilations, including explanations and justifications; assumptions, estimates and judgments, together with the bases, justifications and results; formulas or algorithms used for calculations, together with explanations of inputs or variables used in the calculations." Parties shall serve copies of all filings on other parties by electronic mail on or before the date an electronic copy of the document is filed with the Commission.

#### **DISCOVERY**

Responses to discovery requests served within the following time frames shall be provided within the designated number of days:

Until July 14, 2011, within 21 calendar days. After July 14, 2011, and until September 22, 2011, within 14 calendar days. After September 22, 2011, and until October 25, 2011, within 7 calendar days. After October 25, 2011, within 3 calendar days.

Parties shall serve discovery requests and responses on applicable parties by electronic mail.
