**ROCKY MOUNTAIN POWER'S
REQUEST TO ESTABLISH A
SCHEDULE FOR RATE DESIGN
TESTIMONY AND HEARING**

Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or the “Company”), hereby requests that the Public Service Commission of Utah (“Commission”) establish a new schedule for testimony and hearing in the rate design phase (“Phase II”) of this docket.

In its August 4, 2009 Scheduling Order (“Scheduling Order”) in this docket, the Commission indicated that it would consider a party’s request to vacate the Phase II schedule and set a new schedule therefor at a later scheduling conference. Rocky Mountain Power requests that the Commission vacate the Phase II schedule in this docket and proposes that the Commission set rate design testimony deadlines and hearing as

follows: non-company direct testimony – January 21, 2010; rebuttal testimony – February 25, 2010; surrebuttal testimony – March 15, 2009; hearings – week of March 29, 2010. Rocky Mountain Power objects to any requests to undo the Commission’s ruling in the Scheduling Order to bifurcate the docket. The Commission noted that in bifurcating the case, it was striking a balance of all parties’ interests in both this docket and in Docket No. 09-035-15. Rocky Mountain Power believes that the foregoing schedule accommodates and balances the interests of all parties involved in this docket and in Docket No. 09-035-15.
