In accordance with Rule 746-100-7 of the Public Service Commission's Rules of Practice and Procedure and the Provisions of Utah Code Ann. § 63-46b-9, Kennecott Utah Copper LLC ("Kennecott"), hereby petitions the Public Service Commission ("Commission") for leave to intervene in the above-referenced proceeding.

In support, Kennecott states as follows:

1. Kennecott owns, operates, and maintains a waste heat-fired steam cogeneration facility at its Refinery for the generation of electric power located within the State of Utah and intends to operate the facility as a QF, as that term is defined in 18 C.F.R. Part 292, for delivery of energy to Rocky Mountain.

2. On October 7, 2010, the Company filed its Application for Approval of a PPA with Kennecott to effectuate the sale of power from Kennecott's Refinery QF to Rocky Mountain.

3. Kennecott has a direct, immediate, and substantial interest in this proceeding as the owner of the QF and a counter-party to the PPA. Kennecott's interests will be affected by a Commission decision on Rocky Mountain's Applications.

4. The interests of Kennecott will not be adequately represented by any other party to this proceeding.

5. If granted leave to intervene in this proceeding, Kennecott hereby requests that service of all pleadings, notices, etc. be made to the following:
