Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power” or the “Company”), pursuant to Utah Code Ann. § 63G-4-204 and Utah Admin. Code R746-100-3 and 4, hereby requests additional time to respond to the Application for Deferred Accounting Order for Incremental REC Revenue (“Application”) of the Utah Association

of Energy Users (“UAE”) filed February 22, 2010. Rocky Mountain Power’s response to the Application is due March 24, 2010. The Company, UAE and other parties have held and will continue to hold settlement discussions that would settle the Application and Rocky Mountain Power’s Motion for a Deferred Accounting Order in Docket 09-23-15. While the parties have not reached an agreement, the Company received permission to represent to the Commission that UAE does not oppose this Motion. In the event settlement discussions are unsuccessful, the Company requests that the Commission grant the Company 15 days, from the date the Commission is notified that settlement was not reached, to respond to the Application.
