The Utah Office of Consumer Services respectfully moves for an extension of time within which to file rebuttal testimony and sur-rebuttal testimony. The Office's request would apply to all parties. Under the September 15, 2010 Scheduling Order, rebuttal testimony is now due Thursday November 18, 2010 and sur-rebuttal testimony is due Tuesday November 30, 2010. For the reasons set forth below, the Office requests an extension to Monday, November 22, 2010 to file rebuttal and to Wednesday, December 1, 2010 to file sur-rebuttal. In addition, the Office requests that the parties be permitted until November 29, 2010 to file responsive pleadings to the Motion of Rocky Mountain Power to Strike Pre-

filed Direct Testimony filed on November 8, 2010. Such responses would otherwise be due on Tuesday November 23, 2010.

The Office is requesting this extension because it contends that the November 16, 2010 Decision on UIEC's Application for Review and Clarification together with various parties initial analysis and comments upon it, has a material effect upon the rebuttal and sur-rebuttal testimony that the Office has prepared and upon the analysis of the rate spread and cost of service issues contained in testimony of other parties. The Office believes that its responsive testimony must address the November 16 Decision in conjunction with the October 21, 2010 Order of Clarification. In addition, additional data and analysis has within the last few days been produced by parties that the Office believes may assist the parties in refining the issues to be presented at the hearings in this docket.

Finally, as to the pleadings in response to Rocky Mountain Power's motion to strike, because of the press of other assignments for the Attorney General's Office pending in Third District Court, the Office's counsel requests the extension stated above. The Office also believes that the substance of the motion to strike may in part, be resolved with the filing of updated rebuttal testimony.

The Office believes that this request is both reasonable and justified under the circumstances. Mr. Reeder for UAE, Mr. Mattheis for Nurco, and Mr. Dodge for UAE have stated they have no objection to the Office's motion. The Office has not previously requested an extension. Due to the now effective schedule, the Office requests that the Commission expedite consideration of this motion.
