By The Commission:

By letter dated March 27, 2006, filed in Docket No. 04-999-03, the Commission approved the Utah Pole Attachment Agreement as a “safe harbor” for parties unable to agree to pole attachment terms through negotiation. On February 9, 2012, Rocky Mountain Power, a division of PacifiCorp, filed an amended application requesting approval of changes to the safe harbor agreement. The amended application also seeks approval of a schedule of non-recurring fees to be incorporated into Electric Service Schedule No. 4.

Consistent with the recommendation of the Division of Public Utilities in a memorandum dated March 21, 2012, the Commission gives notice of a scheduling conference to be held on **Monday, April 2, 2012, at 2:00 p.m., in room 401, Heber Wells Bldg., 160 East 300 South, Salt Lake City, Utah.** Parties should come to the conference prepared to discuss whether the proceeding should be formal or informal, and the process and schedule for responding to the amended application.

Individuals wishing to participate in the scheduling conference by telephone should contact the Public Service Commission two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824). Participants attending by telephone should then call the Public Service Commission five minutes prior to the proceeding to ensure participation.
