On July 15, 2012, the Commission granted a two-week extension to the Scheduling Order in Docket No. 10-035-97 because several parties were close to reaching an agreement with respect to this matter and were working on a settlement stipulation.

A Settlement Stipulation has now been executed by Rocky Mountain Power, CenturyLink, Utah Rural Telecom Association, Electric Lightwave, LLC, and is being filed along with this letter. Rocky Mountain Power hereby submits for filing a Settlement Stipulation in the above referenced matter. An original and ten (10) copies of this filing will be provided via hand delivery. The Company will also provide electronic versions of this filing to psc@utah.gov.

Rocky Mountain Power believes that other parties may also sign the Settlement Stipulation, but are not able to execute at this time given scheduling conflicts. As additional parties sign the Settlement Stipulation Rocky Mountain Power will file those signatures with the Commission.

Rocky Mountain Power and the other parties that have executed the Settlement Stipulation request that the Commission consider the Settlement Stipulation in lieu of comments and do not see a need for hearing on the Settlement Stipulation. Other parties may address the Settlement Stipulation in their comments if they desire.
