By The Commission:

On January 25, 2012, the Commission held a duly noticed scheduling conference in this docket to set a procedural schedule for future workgroup meetings, technical conferences and deliverables. The purpose of the workgroup, as established in the Commission's December 21, 2011 order, is to investigate extending and expanding the Solar Incentive Program. Through the cooperative contributions of those in attendance at the scheduling conference, a consensus was reached concerning the process and schedule for examining the various proposals.

As noted in the December 21, 2011 order, the Division is responsible to organize and lead the workgroup's activities. Any interested party may participate in the workgroup and present a strawman proposal for the workgroup's consideration. The parties in attendance at the scheduling conference agreed upon an outline of the basic subjects that should be addressed in each strawman proposal. **Thursday, March 22, 2012:** Third (provisional) technical conference, 9:00 a.m. to 12:00 p.m. (The workgroup will determine whether the third technical conference is needed to address technical interconnection issues or other matters.)
