Rocky Mountain Power, a division of PacifiCorp (“Rocky Mountain Power”) and Qwest Corporation d/b/a CenturyLink (“CenturyLink”) jointly move the Public Service Commission of Utah (“Commission”) to vacate the schedule established for the docket on February 24, 2012, and approve the petition without further proceedings.

Rocky Mountain Power and CenturyLink jointly filed a petition December 7, 2012, requesting the Commission approve the use of an electronic notification system (“ENS”) known as “Notify.” The Commission conducted a duly noticed technical conference and scheduling conference on February 23, 2012. The parties in attendance agreed to March 26, 2012 as the deadline for Initial Comments and Intervention. Comcast filed a notice of intervention on March 26, 2012 but did not file any comments. As of April 2, 2012, no third parties have filed comments; thus, there is no need for the remaining deadlines for Reply and Responses.

WHEREFORE, Rocky Mountain Power and CenturyLink respectfully request that the Commission vacate the remaining dates in the schedule and approve the use of Notify as an ENS based on the information submitted to date without a hearing. Petitioners will submit a draft order upon request.
