SECOND MOTION OF THE DIVISION OF PUBLIC UTILITIES TO AMEND SCHEDULE EXTENDING FILING DATE FOR COST OF SERVICE AND RATE DESIGN REBUTTAL TESTIMONY AND FOR EXPEDITED CONSIDERATION

Pursuant to R746-100-4, the Division of Public Utilities (“Division”) files this Second Motion to Amend Schedule Extending Filing Date for Cost of Service and Rate Design Rebuttal Testimony and for Expedited Consideration (“Second Motion”). A draft of this Second Motion was circulated Tuesday, July 31, 2012 to the parties in this docket. The Division is authorized to represent that Rocky Mountain Power; the Office of Consumer Services; the Utah Association of Energy Users; the Utah Industrial Energy Consumers; Utah Clean Energy; the Federal Executive Agencies; Walmart, Inc.; Sam’s West, Inc.; and Kroeger support the Second Motion, and that AARP, Salt Lake Community Action Program, US Magnesium, and Nucor do not object to the

Second Motion. The Division has not received notice of any objections to the Second Motion.

On July 26, 2012, the Public Service Commission (“Commission”) granted the Division’s first motion to extend the filing date for cost of service and rate design rebuttal testimony, and for expedited consideration of the same. That July 26, 2012 order changed the filing date for cost of service and rate design rebuttal testimony from July 27, 2012 to August 2, 2012.

Because of ongoing settlement discussions, the Division seeks to extend for a second time the filing date for Cost of Service and Rate Design Rebuttal Testimony. The Division seeks to extend the filing date by five calendar days, resulting in a change of the filing date from Thursday, August 2, 2012 to Tuesday, August 7, 2012. Due to the approaching Thursday filing date, the Division also respectfully requests that the Commission expeditiously consider this Second Motion.
