Pursuant to the discussion and agreements reached at the scheduling conference held October 13, 2011, in this matter, the Commission establishes the following schedule:

<b>Monday, December 12, 2011</b>	Hearing The hearing in this matter will begin on December 12, 2011, at 9:00 a.m., in <b>Fourth Floor Room 403, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.</b>

The application for approval of a solicitation process which is the subject of this docket was filed on October 5, 2011. Utah Code Ann. § 54-17-201(2)(f) requires Commission action on the application within 60 days of that date, unless the Commission determines additional time to analyze the proposed solicitation process is warranted and in the public interest. The parties have agreed upon a schedule which is incompatible with the statutory

deadline in order to permit the requisite level of analysis. We find the deviation from the statutory time for review to be warranted in this case and in the public interest.

Participants attending by telephone should then call the Public Service Commission five minutes prior to the hearing to ensure participation.

All parties shall reply to requests for data or discovery within seven calendar days of receipt, on a best efforts basis. Participants desiring paper copies of material, in lieu of an electronic version, must specifically request such production and delivery. The Commission welcomes the public's written comments in this docket. They can be filed with the Commission by the applicable due date at [psc@utah.gov](mailto:psc@utah.gov).
