By The Commission:

Pursuant to the request of the Division of Public Utilities (“Division”), filed October 1, 2012, a Technical Conference is hereby scheduled for **Thursday, October 25, 2012, at 1:30 p.m.** It will be held in **Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah.** The purpose of the conference is for PacifiCorp to answer questions and explain to interested parties the facts and reasons behind the termination of the solicitation process for the All-Source Resource for the 2016 time period (“All Source RFP”).

Also, in its October 1, 2012 memorandum to the Commission, the Division recommends the Commission clarify its procedural expectations for this matter in light of the Company’s decision to cancel the All Source RFP as described in the Company’s September 28, 2012, notification to the Commission. In a separate memo, also filed October 1, 2012, the Division recommends the Commission approve the change to the approved solicitation process schedule in this matter caused by upgrades to the Company’s modeling tools described by the Company in its letter to the Commission dated September 10, 2012.

Based on the Division’s recommendations, the Commission approves the schedule change required due to the modeling upgrades. Further, the Commission suspends the remaining All Source RFP schedule pending further Order following the Technical Conference

noticed herein. This includes the suspension of further reports required by the Utah Independent Evaluator until further notice.

Participants attending by telephone should then call the Public Service Commission five minutes prior to the conference to ensure participation.
