Avoided Cost Purchases from Qualifying Facilities (QF)**

On October 31, 2011, the Utah Public Service Commission issued an order requesting additional information under Docket No. 11-035-T06. The Commission ordered PacifiCorp, dba Rocky Mountain Power (“Company”) to file supplementary information by November 14, 2011 regarding its application of the Commission approved methodology to calculate Schedule No. 37 avoided cost rates (“Commission Approved Methodology”). The enclosed filing is in response to the Commission’s Order.

Enclosed for filing are an original and two copies of proposed tariff sheets associated with Tariff P.S.C.U No. 47 of PacifiCorp, d.b.a Rocky Mountain Power, applicable to electric service in the State of Utah. Pursuant to the requirement of Rule R746-405D, PacifiCorp states that the proposed tariff sheets do not constitute a violation of state law or Commission rule. PacifiCorp will also provide an electronic version of this filing to [psc@utah.gov](mailto:psc@utah.gov). PacifiCorp respectfully requests an effective date of December 14, 2011.

The 2011 non-levelized prices and the 20 year levelized prices in the enclosed tariff sheets have been updated to reflect the correction of an error in the Company’s initial filing. In that filing the capacity calculation for the 6 month period July to December 2011 was assumed to be paid over a 12 month period. The revised prices correctly reflect that the capacity payment is paid over a six month period.

Included with this filing is Attachment A that provides the Company’s response to the Commission’s Order. Also included are Attachment B with Tables 1 through Tables 11 that
