On March 30, 2012, PacifiCorp ("Company"), doing business in Utah as Rocky Mountain Power, filed its 2011 Integrated Resource Plan Update ("Update"). This filing includes an updated Action Plan. In accordance with Utah Admin. Code R746-430-1(2)(a), the Commission hereby gives notice of a scheduling conference.

The purposes of the conference will be: 1) to set a schedule for interested parties to obtain information and prepare comments on the Update, 2) to set the dates upon which comments and reply comments may be filed, and 3) to receive parties' recommendations concerning whether the Commission should hold hearings in connection with the updated Action Plan.
