MOTION FOR ORDER PERMITTING RANDALL J. FALKENBERG TO APPEAR AT HEARING TELEPHONICALLY

The Utah Office of Consumer Services ("OCS"), through its legal counsel, respectfully moves the Public Service Commission for an Order permitting one of its expert witnesses, Randall J. Falkenberg, to appear at the hearing in this matter via telephone.

The basis for this Motion is that on or about April 27, 2013 Mr. Falkenberg sustained a serious leg injury in an accident that occurred in his home state of Georgia. As a result of Mr. Falkenberg's injury, his treating physician has restricted him from airline travel for up to 3-4

months. Inasmuch as the hearing on this matter is scheduled for June 5th and 6th, Mr. Falkenberg's medical condition will not allow him to be physically present at the hearing.
