By The Commission:

This matter is before the Commission on the stipulated motion of US Magnesium LLC (“US Mag”) filed January 17, 2013. US Mag represents that all parties to this docket either support or do not oppose the following procedural actions:

1. Severing all issues relating to the proposal of the Office and the Division to apply the Energy Balancing Account to special contract customers, from the remaining issues in the docket; and,
2. Amending the date for the filing of surrebuttal testimony on the severed issues to February 1, 2013.

The foregoing procedural changes are approved. At the hearing on the remaining issues to be held **Friday, February 1, 2013, commencing at 9:00 a.m., in Room 403, Heber M. Wells Building, Salt Lake City, Utah**, US Mag and other interested parties shall present their proposals for addressing the severed issues such that the severed issues can be resolved in a final Commission order by February 28, 2013. As noted in the stipulated motion, this timing will allow the rate spread implications of the treatment of special contracts to be implemented in the Commission’s final order in this docket, which the Commission expects to issue in early March 2013.
