For discovery requests served prior to April 27, 2012, responses shall be served within fourteen calendar days. For discovery requests served on or after April 27, 2012, responses shall be served within four calendar days, unless the fourth day falls on a weekend or state holiday, in which case the discovery request shall be served the next business day. Where feasible, parties shall serve discovery requests and responses on applicable parties by electronic mail.

At the scheduling conference, the Division of Public Utilities informed the parties it would complete its audit and file its final audit report by September 14, 2012. Following the distribution of this report, the Commission will hold another scheduling conference to determine what, if any, further process is required prior to the interim rate changes established in this docket becoming final on about October 12, 2012. **This scheduling conference will be held at 10:00 a.m. on Tuesday, September 18, 2012, in Room 401, Heber Wells Bldg., 160 East 300 South, Salt Lake City, Utah.**
