By The Commission:

On March 16, 2012, PacifiCorp, a public utility doing business in Utah as Rocky Mountain Power -- joined by the Division of Public Utilities, the Office of Consumer Services, and several other parties -- filed a request for agency action ("Request") seeking the creation of a DSM Steering Committee ("Committee"). In summary, the purpose of the Committee would be to receive input on DSM issues involving sensitive, confidential or proprietary information and to conduct settlement negotiations in matters before the Commission. The Request describes certain qualifications for Committee membership and limits total membership to a maximum of twelve members.

The Commission held a duly noticed scheduling conference on March 29, 2012. Based on the discussion at the conference, the schedule presented in the following table is established for submitting comments on the Request.
