On September 4, 2012, PacifiCorp, a public utility doing business in Utah as Rocky Mountain Power, delivered to the Commission a letter requesting the Commission to open the above-captioned docket and schedule a procedural conference. The letter also requests a waiver of the Commission's prior order requiring a filing for approval of an electric service agreement between these parties to be submitted at least 75 days before a hearing.
