ISSUED: May 4, 2012

By The Commission:

On April 6, 2012, PacifiCorp (“Company”), d/b/a Rocky Mountain Power, filed an application for approval of the proposed removal of the March 31, 2014, expiration date from Schedule 192 Self-Direction Credit (“Self-Direction Credit”) and Schedule 193 Demand-side Management Cost Adjustment (“DSM Cost Adjustment”). In the filing, the Company also requests administrative changes to the DSM Cost Adjustment. The Company requests an effective date of May 6, 2012.

On April 6, 2012, the Commission issued an Action Request to the Division of Public Utilities (“Division”) for a review of the Company’s filing. On April 25, 2012, the Commission received comments from the Office of Consumer Services (“Office”) recommending approval of the Company’s proposed modifications to Schedules 192 and 193 as filed. On April 30, 2012, the Commission received comments from the Division regarding the Company’s proposed modifications. The Division also recommends the Commission approve these changes. However, in their comments, the Division proposes minor modifications to the tariff language in Schedule 192.

We note both the Division and the Office recommend the Company's proposed changes be approved with only minor modifications identified by the Division. We direct the Company to modify the tariff language in Schedule 192, per the Division's recommendations. We also direct the Company to file a review of the Self-Direction Credit program and the DSM Cost Adjustment by March 31, 2014, as recommended by the Company in its filing.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that:

1. The tariff sheets are approved with the Division's recommended modifications with an effective date of May 6, 2012.
2. The Company shall modify the tariff language per the Division's recommendations and shall file corrected tariff sheets for compliance review.
