ORDER SUSPENDING SCHEDULING
ORDER AND NOTICE OF HEARING

ISSUED: August 20, 2013

By The Commission:

On February 8, 2013, the Commission issued Notices of Scheduling Order, Technical Conference, and Hearing in this docket. The remaining Scheduling Order items include the filing of surrebuttal testimony on August 27, 2013, and a hearing on September 11-12, 2013.

On August 19, 2013, Rocky Mountain Power, a Division of PacifiCorp (“PacifiCorp”) filed notice that PacifiCorp and the intervening parties in this docket reached an agreement in principle settling all outstanding issues. The notice indicates the settling parties intend to file a stipulation memorializing the settlement with the Commission no later than August 29th. Accordingly, the notice requests the August 27th filing date for surrebuttal testimony be suspended. The parties further request the Commission maintain the current hearing date of September 11th, at which time the parties will provide testimony in support of the stipulation.

Based on the foregoing, and for other good cause appearing, the Commission suspends the scheduling order entered in this docket on February 8, 2013. This suspension does not apply to pending or future discovery.

NOTICE OF HEARING

Notice is given that a hearing in the above-entitled matter will be conducted by Public Service Commission of Utah on **Wednesday, September 11, 2013, beginning at 9:00 a.m. (MDT)**. The hearing will be held in the **Fourth Floor Hearing Room 403, Heber M. Wells Bldg., 160 East 300 South, Salt Lake City, Utah**. All parties must have their witnesses in attendance and prepared to testify.
