Thank you for your interest in obtaining a PPA. In response to your request, Section I.B.4 of Schedule 38 requires that the developer provide the following information in order to receive a draft power purchase agreement:

- a) updated information of the categories described in Paragraph B.2;
- b) evidence of adequate control of proposed site;
- c) identification of, and timelines for obtaining any necessary governmental permits, approvals or authorizations;
- d) assurance of fuel supply or motive force;
- e) anticipated timelines for completion of key Project milestones; and
- f) evidence that any necessary interconnection studies have been completed and assurance that the necessary interconnection arrangements are being made in accordance with Part II.

Please provide this information and we can then provide the draft PPA pursuant to Schedule 38. Email response with the information is sufficient. Let me know if you have any questions.
