Hi Kim,

Just heard from our planner that uses the PSS/E models, and it sounds like, unfortunately, that the model you sent in to us may have issues. We previously received the Gamesa turbine's model for another project's study and there were issues with that model when we tried to run it in our transient stability studies. I can't tell you for sure that the version you gave us is good or not without actually plugging it into our system and letting it run. Our planning group is working with Gamesa to get the issues sorted, but I don't have a status on that fix.

I'll have Tom follow up with you next week about what some potential next steps may be.
