1. Petitioner has provided Utah Air Conditioning Load Control Services for PacifiCorp pursuant to a contract with PacifiCorp for the past ten years, through the PacifiCorp’s Cool Keeper program.

2. The legal rights and interests of Petitioner will be substantially affected by this proceeding.

3. Petitioner seeks to intervene for the purpose of protecting its interests as they may appear, including its ownership interest in load control devices on air conditioning systems in Utah, currently on approximately 110,797 locations. See Rocky Mountain Power’s Application, Paragraph 15.
