ORDER APPROVING CUSTOMER SERVICE AGREEMENT

By The Commission:

On October 4, 2013, Rocky Mountain Power, a division of PacifiCorp (“PacifiCorp”), filed a request for approval (“Request”) of its agreement with Hurricane City, Utah (“City”) whereby the City agrees to allow PacifiCorp to provide electric service to a certain customer (“Additional Customer”) located within the City’s municipal boundaries (“Agreement”). PacifiCorp indicates the City and PacifiCorp entered into the Agreement, subject to the Commission’s approval, in compliance with Utah Code Ann. §§ 54-3-30 and 54-4-40.

On November 5, 2013, the Division of Public Utilities (“Division”) filed a response to the Commission’s October 7, 2013, Action Request, recommending approval of the Agreement. According to the Division, the Additional Customer requested electric service from PacifiCorp due to the City’s apparent inability to provide increased electric service. The Division further indicates that because PacifiCorp currently serves approximately 140 customers located within the City’s municipal boundaries, PacifiCorp has distribution facilities in place located near the Additional Customer to provide the requested service. Finally, the Division indicates that none of its existing customers will be harmed by providing electric service to the Additional Customer.

The Commission has not received any opposition to PacifiCorp’s Request.

Notice of Opportunity for Agency Review or Rehearing

Pursuant to Utah Code Ann. §§ 63G-4-301 and 54-7-15, a party may seek agency review or rehearing of this order by filing a request for review or rehearing with the Commission within 30 days after the issuance of the order. Responses to a request for agency review or rehearing must be filed within 15 days of the filing of the request for review or rehearing. If the Commission fails to grant a request for review or rehearing within 20 days after the filing of a request for review or rehearing, it is deemed denied. Judicial review of the Commission's final agency action may be obtained by filing a Petition for Review with the Utah Supreme Court within 30 days after final agency action. Any Petition for Review must comply with the requirements of Utah Code Ann. §§ 63G-4-401, 63G-4-403, and the Utah Rules of Appellate Procedure.
