On January 23, 2014, Holcim, Inc., Kennecott Utah Copper LLC, Kimberly-Clark Corp., Malt-O-Meal, Praxair, Inc., Proctor & Gamble, Inc., and Tesoro Refining and Marketing Co., collectively referred to as the Utah Industrial Energy Consumers (“UIEC”), petitioned for leave to intervene in this docket.

Based upon the request to intervene and for good cause appearing, the Commission will grant intervention.
