TESTIMONY AND MOTION FOR  
AMENDED SCHEDULE**

Pursuant to Utah Admin. Code R. 746-100-4 the Utah Division of Public Utilities (“Division”) hereby withdraws its Motion for Extension of Time to File Audit Report and Direct Testimony in the above referenced docket. The Division further requests that the Commission approve the amended schedule as set forth below.

The April 12, 2013 Amended Scheduling Order and Notice of Hearing in this docket set the filing date for the Division’s audit report as July 12, 2013. On June 21, 2013 the Division filed a Motion for Extension of Time to File Audit Report and Direct Testimony requesting a 14 day extension. After discussion with all current parties to this docket, the Division withdraws its Motion for a 14 day extension and requests that the Commission amend its schedule as follows.

DPU Audit Report and DPU Direct Testimony	Monday, July 22, 2013
Intervenor Direct Testimony/Company's Response to DPU Audit Report and DPU Direct Testimony	Tuesday, August 20, 2013
Intervention Deadline	Friday, August 30, 2013 (no change)
Rebuttal Testimony – All Parties	Friday, September 20, 2013
Surrebuttal Testimony – All Parties	Friday, September 27, 2013
Hearing	Wednesday, October 2, 2013 at 9:00 a.m. (no change)

The Division proposes that the discovery response time be set at fourteen calendar days prior to July 22, 2013, seven calendar days between July 22, 2013 and September 20, 2013 and 3 business days after September 20, 2013.

The proposed schedule allows additional time for the Division to complete its audit report. It provides sufficient time for the parties to consider the Division's audit report in evaluating and drafting their respective filings. And it retains the original hearing date set by the Commission as well as the time frame for the Commission to issue its order if it wishes rates to become effective by the milestone date of November 1, 2013. All parties to this docket have been contacted and either approve or do not object to this amended schedule.

For these reasons the Division withdraws its June 21, 2013 Motion and requests that the Commission amend the schedule as set forth above. For the same reasons set forth in the June

21, 2013 Motion the Division requests that response times be shortened and the Commission expedite consideration of this Motion.
