#### DISCOVERY

In the event a document filed with the Commission or produced in response to a discovery request cannot reasonably be transmitted by electronic mail, the party filing the document shall file an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) with the Commission by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.

#### COMMENT DEADLINE REGARDING TECHNICAL CONFERENCE

At the scheduling conference, interested parties indicated a technical conference on the non-confidential/confidential information contained in Volumes I and II/Volume III of PacifiCorp's 2013 IRP may be unnecessary to inform their comments. As such, the interested parties agreed to express their preference for such a technical conference by emailing the Commission's designated Presiding Officer, Jordan A. #### NOTICE OF TECHNICAL CONFERENCE

The Commission will hold a technical conference on **Wednesday**, July 31, 2013, beginning at 10:00 a.m. (MDT). The technical conference will be held in the Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of the technical conference is to address <u>non-confidential</u> information contained in Volumes I and II of PacifiCorp's 2013 IRP. We request PacifiCorp to lead the discussion.

The Commission will hold a technical conference on **Wednesday**, July 31, 2013, beginning at 1:30 p.m. (MDT). The technical conference will be held in the Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. The purpose of the technical conference is to address <u>confidential</u> information contained in Volume III of PacifiCorp's 2013 IRP. We request PacifiCorp to lead the discussion.

Interested parties planning to attend the confidential portion of the July 31, 2013, technical conference must: (1) execute a non-disclosure agreement; and (2) be granted intervention by the Commission. Past IRP proceedings have not required formal intervention. However, unlike previous IRPs, PacifiCorp's 2013 IRP includes confidential information contained in Volume III. Therefore, in accordance with Utah Admin. Code R746-100-16, the Commission will require both formal intervention and execution of a non-disclosure agreement to attend the confidential portion of the July 31, 2013, technical conference.

Parties shall serve copies of all filings on other parties by electronic mail <u>at or</u> <u>before</u> the time an electronic copy of the document is required to be filed with the Commission.
