**RE: TARIFF REVISIONS - TICABOO UTILITY IMPROVEMENT DISTRICT TARIFF NO. 1**

Commission,

Enclosed with this letter please find a revision to Tariff No. 1 for the Ticaboo Utility Improvement District ("District"), originally filed and accepted under Docket # 13-2508-T01. Due to the number of changes, the enclosed modified tariff replaces the old Tariff No. 1 in its entirety.

The enclosed tariff includes many changes and updates; however, many of these changes are insignificant and directly related to composition, format, grammar, and corrections that do not affect the substance of the tariff. The list below highlights the substantive changes to the Electric Service Rate Schedules and Electric Service Regulations, which together make up the District's new tariff:

- Electric Service Regulations Original Sheet Numbers are now designated alpha numerically beginning with "ER-".
- Electric Rate Schedules Original Sheet Numbers are now designated alpha numerically beginning with "ES-".
- Additions/Deletions/Changes:
  - Electric Service Regulations
    - Section 1.01: The Mission Statement section was removed and the General Information Section was modified to refer to the Administrative Rules and Regulations Manual being prepared by the District.
    - Section 1.02: Details of Board membership and function was removed and a reference to the Administrative Rules and Regulations Manual was added.
    - Section 1.03: Language was added defining the Tariff as being the Electric Service Regulations together with the Electric Service Rate Schedules.
    - Section 2.01: Various definitions were added in order to make the regulations more clear, including definitions for "Active Connection", "Contiguous Property", "Hookup Fee", "Impact Fee", "Property Owner", "Service Classification", "Solid Waste Service", "Standby Connection", "Tap", and "Tariff".

- Section 03.02 Requirement of Other Utility Services, was added in accordance with a resolution unanimously adopted by the Board of Trustees.
- Section 03.03 Standby Fees, was added in accordance with a resolution unanimously adopted by the Board of Trustees.
- Section 3.08: Language was added to address payment of standby fees after cancellation of service.
- Section 3.09: Language was added addressing the consequences of noncompliance with requirements of other District-provided utility services.
- Section 03.12 Abandonment of Utility Services, was added in accordance with a resolution unanimously adopted by the Board of Trustees.
- Section 4.02: Language was added addressing the possibility of residential properties with multiple structures.
- Section 8.01 was added to describe the “unified billing” policy adopted by the District.
- Section 10.01: Language was added describing consequences for nonpayment for any District utility service.
- Section 10.06: Language was added to address disconnection as a result of various actions and omissions.
- Regulation R13 was removed in its entirety and will be included in the Administrative Rules and Regulations manual the District is preparing.
- Electric Rate Schedules;
  - Electric Rate Schedule No. 4, formally Original Sheet No. 4-1, has been changed to "Schedule RC" beginning with RC-1 to consolidate all of the nonrecurring utility service charges of the District into one document. All other schedules previously following 4-1 have been moved up to fill the vacancy (e.g. Previous schedule No. 5, is now No. 4, and so on). Stated amounts for various fees in the Schedules have been changed to references to the particular fee on Schedule RC.
  - All Schedules: Various changes were made to make the terms, and the order in which those terms are presented, consistent across the various schedules.
  - All Schedules: The word "inactive" was removed, and replaced with "Standby Fee"; “Customer Charge” has been changed to “Customer Service Charge”; “New Connection Fee” has been changed to “Hookup Fee”.
  - All Schedules: Standby fees are now expressed as dollar amounts, rather than as a multiple of the Customer Service Charge.
  - All Schedules: Wording added to clarify the payment of reconnection fees after disconnection from the system.
  - All Schedules: Wording added to clarify the payment of Connection Fees.
  - All Schedules: The Surcharge Adjustment has been removed.
  - All Schedules: Wording added to the rate schedules to address other fees.
  - Residential Electric Rate Schedules: Wording added to define the method of calculating minimum monthly charges for a single meter that serves multiple dwellings or apartments.

- Schedule Nos. 4 - 10: Language added to clarify that the annual period for calculating electric usage begins on June 1<sup>st</sup>; language added to clarify that electric usage below the specified threshold is included in the Customer Service Charge.

The District respectfully requests the Commission acknowledge the revised tariff sheets of the Ticaboo Utility Improvement District and make them available for public inspection.
