Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Utah Clean Energy, petitions for leave to intervene in this docket. In support of this petition, Utah Clean Energy states as follows:

1. The Commission's Report and Order in Docket No. 13-035-184, issued on August 29, 2014, established the above-captioned docket for the development of an analytical framework to evaluate the costs and benefits of Rocky Mountain Power's (the Company's) net metering program.

2. On March 30, 2015, the Commission issued an *Errata and Second Order Amending Scheduling Order* and set a deadline of April 9, 2015 for petitions for intervention by parties that wish to participate in confidential settlement meetings.

3. Utah Clean Energy is a state-based, non-profit, public interest organization working to create healthy, thriving communities, empowered and sustained by clean energy. Our mission is to lead and accelerate the clean energy transformation with vision and expertise. Our work

focuses on preventing wasted energy, facilitating clean energy and creating a smart energy future.

4. Utah Clean Energy was granted intervenor status in Docket No. 13-035-184 and participated in the net metering phase of that docket, urging the Commission to reject the Company's proposed residential net metering facilities charge and to establish a proceeding to fully and transparently evaluate the costs and benefits of net metering.

5. Utah Clean Energy's legal rights and interests may be substantially affected by this proceeding.

6. Utah Clean Energy has not fully determined specific positions it will take or the relief it will seek. Utah Clean Energy seeks to intervene for purposes of protecting its interests as they arise.

5. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Utah Clean Energy to intervene.

6. Utah Clean Energy's interests are not adequately represented by another party in this proceeding.
