REMINDER from DPU

The Division of Public Utilities ("Division") is required to file an agenda with the Public Service Commission of Utah ("Commission") at least seven days in advance of each workgroup meeting. The Division requests that any party, having been granted intervention by the Commission, wishing to present during this workgroup meeting, submit their intent to do so, topic, presenter's name or names, time required, and media requirements to the Division no later than June 10, 2015 to radavis@utah.gov for the meeting scheduled on June 25, 2015. The topic to consider for this workgroup should be focused on the DSM tests and how they might be applied to the Net Metering Program. Please provide the Division with presentation materials two days in advance of the session so they can be made available to phone participants.

Background

On January 14, 2015, the Commission issued a Scheduling Order and Notices of Technical Conference and Hearing (“Scheduling Order”). Pursuant to the Scheduling Order, the Commission convened a Technical, Status and Scheduling Conference (“Scheduling Conference”) in this docket on March 16, 2015.

On March 19, 2015, the Commission issued its First Order Amending Scheduling Order and Notices of Workgroup Meetings, Hearing and Public Witness Hearing. Parties at the Scheduling Conference agreed to form an informal workgroup led by the Division to discuss various topics including, but not limited to, the topics identified in the Commission’s notice of March 9, 2015. These workgroup sessions are intended to be a presentation of facts and should not be a forum for advocacy. The third workgroup, open to the public, will be held Thursday, June 25, 2015, beginning at 9:00 a.m. (MDT), Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah. An Intervenor’s only discussion will be held following the public session from 1:30 to 4:00. Individuals wishing to participate in the workgroup meeting by telephone should call **1-877-820-7831** and enter passcode **342629#**.

The Division is required to file an agenda with the Commission at least seven days in advance of each workgroup meeting. The Division requests that any party, having been granted intervention by the Commission, wishing to present during this workgroup meeting, submit their intent to do so, their topic, name or names of presenter(s), time required, and media needs to the Division no later than June 10, 2015 to radavis@utah.gov. In addition, the parties should file their costs and benefits matrix including the category name of the cost or benefit and a brief description by June 10, 2015 in Excel format. It would be helpful to categorize similar costs or benefits under one category. Please provide presentations to the Division two days prior to the workgroup session so they can be provided to those participating by phone.
