I'm not sure who, if anyone, will read this message; but I am a rooftop solar customer and had some interesting thoughts on how Rocky Mountain Power could turn the rooftop solar craze into a competitive advantage. I don't know how to get these thoughts in front of decision makers, I'll try to send them to executives at RMP, but I thought that it might be beneficial for the PSC to see them as well. Perhaps they could be the start of some fruitful discussions.

I think that Rocky Mountain Power is missing a g olden opportunity hee. Rather than fight the technology and trends they should embrace them. Instead of alienating rooftop solar customers, start by proposing reasonable metering fees; since most people understand that solar customers still use lines that have to be maintained. Next, approach rooftop solar subscribers with the proposal that Rocky Mountain Power would like to cover the cost of adding additional panels to the solar array. In exchange, RMP will proportionally reduce or eliminate the metering fees, since the cus tomer is now adding value to the system. The synergy here is wonderful. The customer has voluntarily accepted the responsibility of paying for the installation of all the necessary hardware leaving RMP with only the relatively minor marginal cost of adding panels (that RMP could probably acquire for a reduced rate based on volume purchasing); the solar company gets to sell more panels (which is what they are in the business of doing anyway); and RMP gets to start generating really cheap power that they can then sell to other customers. Not all homes, customers, or locations are really conducive to solar power generation, so there will never be total saturation of this market. Even in the enormously unlikely event that Utah starts generating a surplus of electricity, it could easily be sold in another locale such as the Pacific Northwest; and if the metrics begin to move, RMP could just phase back the program. Capitalizing on the opportunity represented by the diversified, low-cost, power generation of rooftop solar technology is a much more winning proposition than trying to hold back the tides of public opinion. Let's make Utah a leader in clean power innovation.
