PETITION TO INTERVENE OF LEGEND
VENTURES LLC, dba LEGEND SOLAR,
LLC

Pursuant to Utah Code Ann. § 63G-4-207 and Rule R746-100-7, Legend Ventures, LLC, dba Legend Solar, LLC (hereinafter "Legend Solar"), by and through its counsel, Nathan K. Fisher and Benjamin C. Van Noy, of the law firm Fisher & Hunter, LLC, hereby requests that the Commission grant its Petition to Intervene in Docket No. 14-035-114. In support of this Petition, Petitioner states as follows:

1. On August 29, 2014, the Commission issued its Report and Order in Docket No. 13-035-184, establishing this docket to investigate and develop an analytical framework to evaluate the costs and benefits of PacifiCorp's net metering program.

2. On November 9, 2016, PacifiCorp filed its Compliance Filing and Request to Complete All Analysis Required Under the Net Metering Statute for the Evaluation of the Net Metering Program.
3. On November 18, 2016, the Commission issued a Scheduling Order and Notices of Hearing and Public Witness Hearing, and set December 20, 2016 as the deadline to intervene for parties desiring to participate within this docket as an intervening party.
4. Legend Solar is a Utah limited liability company authorized to conduct business in the State of Utah, and headquartered in St. George, Utah.
5. Legend Solar is the fastest growing solar energy provider in Utah, and provides solar energy services pursuant to PacifiCorp's net metering program to residential and commercial customers throughout the state. A significant portion of Legend Solar's residential and commercial customers are active participants in PacifiCorp's net metering program.
6. The outcome of Docket No. 14-035-114 may substantially affect Legend Solar's rights and interests, including the rights and interests of many of Legend Solar's residential and commercial customers because the vast majority of Legend Solar's residential and commercial customers and potential customers are within the PacifiCorp's service area.
7. The interests of justice and the orderly and prompt conduct of this proceeding will not be materially impaired by allowing Petitioner to intervene.
