The petition states:

"Stop Rocky Mountain Power from Killing Residential Solar in Utah Over the last year, Rocky Mountain Power's sister company killed 99% of residential solar in Nevada. Now, Rocky Mountain Power is trying to do the same thing in Utah, by asking the Utah Public Service Commission to approve one of the most aggressive, anti-consumer, anti-competitive, and anti-solar proposals ever brought forth by a utility in the United States. The Commission is required to study the costs and benefits of residential solar in Utah. Most states have found that residential solar provides a net benefit to everyone, not just solar customers. Rocky Mountain Power ignores the full benefits and demonstrated cost-savings that they and all Utahns receive from residential solar. Utah deserves an open and transparent cost-benefit study. We call on Governor Herbert, the Utah Legislature, the Utah Public Service Commission, the Utah Division of Public Utilities, and the Utah Office of Consumer Services to reject Rocky Mountain Power's proposal. We ask the Commission to conduct a robust and fair cost-benefit study so that Utah homeowners can continue to invest in solar and energy independence."

Not to mention it was submitted when the country was distracted with the presidential election with the deadline right on the cusp of the Thanksgiving holiday, when people are readying themselves to host family and friends or traveling out of state. One might conclude that this time period was pre-meditated to provide an optimum environment of eschewing public commentary. I understand there is a "second" deadline in June, however, the push for an imminent minimum rate schedule to be put in place for the citizens of Utah who have yet to purchase residential solar panels, could be foul-play. Ultimately, this move by Rocky Mountain is antithetical in making our government body more accountable to the clean air we, the people, are entitled to along the Wasatch front. The people of Utah want our state to be economically viable in renewables in a world increasingly turning to renewable, alternative energy sources. The people of this state do not support Rocky Mountain burning coal and gas to bring electricity to our homes, while those who are actually generating power and giving it back "free of charge" to the grid are levied surcharges for doing so. The absurdity of this is not lost on the thinking public! Forcing us to stay on the grid actually is a red flag to Rocky Mountain – who needs to change their business model, and plan for a future of more and more residential and commercial solar use.
