**AMENDED JOINDER IN MOTION TO  
AMEND SCHEDULING ORDER  
(with additional terms)**

**(Expedited Consideration Requested)**

On August 10, 2017, certain parties (the "Joint Movants")<sup>1</sup> filed a Motion to Amend Scheduling Order ("Motion") requesting that the hearing currently scheduled to begin on August 14, 2017 be postponed to begin on September 18, 2017. The Motion was premised on settlement discussions that had been occurring between the parties, and the Joint Movants' expectations that

a stay in the proceedings would facilitate settlement. The Motion also requested that the Commission issue a decision on the Motion the same day it was filed.

On August 11, 2017, the Commission issued a Notice Regarding Motion to Amend Scheduling Order (“Notice”) that denied that Joint Movants’ request for a same-day decision without agreement of other parties, and instead instructed the parties to “be prepared to discuss the motion to amend scheduling order at the beginning of the hearing scheduled to begin on August 14, 2017.”

Given additional developments in settlement discussions since the Motion was filed, PacifiCorp d/b/a Rocky Mountain Power (the “Company”) now joins the Motion and asks the Commission to issue an order striking the hearing set to begin on August 14, and set a new hearing to begin on September 18 and continuing through September 22.

The Company notes that an additional hearing date for the purpose of ratifying any settlement stipulation reached by the parties would be beneficial for the parties and Commission if convened *prior to* the September 18 hearing date. Parties agreeing to a particular proposed date will file a separate request for such a hearing as soon as practicable.
