On May 21, 2014, Rocky Mountain Power, a division of PacifiCorp (“PacifiCorp”), filed an application for approval of advance authorization to transfer spare transformers pursuant to a sharing agreement (“Application”). **DISCOVERY**

available, a paper copy) with the Commission by hand delivery and shall serve an electronic copy of the document on CD (or, if an electronic copy is not available, a paper copy) on each applicable party by hand delivery if the party being served is in the same metropolitan area as the serving party, or by overnight courier if the party being served is located in a different metropolitan area from the serving party.
