NOTICE OF FILING AND COMMENT PERIOD

Rocky Mountain Power, dba PacifiCorp (“PacifiCorp”), filed a request on June 12, 2014, for approval of agreements with the following twenty-six separate Utah municipalities: Beaver City; Bountiful City; Blanding City; Ephraim City; Fairview City; Holden Town; Hurricane City; Hyrum City; Kaysville City; Lehi City; Town of Levan; Logan City; Manti City; Monroe City; Morgan City; Mt. Pleasant City; Murray City; Nephi City; Town of Oak City; Town of Paragonah; Parowan City; Price City; Provo City; Spring City; Springville City; and St. George City (collectively referred to hereafter as the “Municipalities”).
