**RE: Docket No. 14-035-T14 – In the Matter of Rocky Mountain Power’s Proposed Revisions to Electric Service Schedule No. 193, Demand Side Management (DSM) Cost Adjustment**

Dear Public Service Commission,

On December 31, 2014 Rocky Mountain Power filed its proposed revisions to Schedule 193, Demand Side Management (DSM) Surcharge, and on January 14, 2015 the Commission issued a Notice of Hearing and Comment Period asking any interested parties to submit comments on Rocky Mountain Power’s proposed revisions on or before January 21, 2015. Utah Clean Energy and the Southwest Energy Efficiency Project (SWEEP) are submitting these comments in support of the proposed increase to Schedule 193.

Utah Clean Energy and SWEEP support Rocky Mountain Power’s proposal to adjust the Schedule 193 DSM Surcharge. We believe that the two-step increase proposed by Rocky Mountain Power of its DSM collection rate is reasonable and will help maintain a strong level of DSM program funding. We feel that the 24 month adjustment period established by Rocky Mountain Power, which is projected to bring the account balance back into equilibrium, is fair. Given that Rocky Mountain Power plans on reevaluating the collection rate in this 24 month period, we believe that this two-step increase would help the customers plan in advance for the increase during 2016.
