On March 30, 2015, following a properly noticed public meeting of its members, Garkane Energy's Board of Directors approved changes to the schedules in the Utah Tariffs (listed below). Garkane notified its members of the change in rates in its quarterly newsletter, HIGHLIGHTS, that was mailed on April 1, 2015. The changes from the hearing will take affect from April 30, 2015 forward. The rate tariffs are listed below:


1. **RES21** - Residential Service – increased the base rate to \$22.00. The first 1,000 kWh's used - \$0.07180 per kWh. Over 1,000 kWh's used - \$0.06680 per kWh. Also increased the Minimum bill to \$35 per month. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
2. **IRR24** - Irrigation Service – increased base rate to \$30.00. The first 10,000 kWh's used - \$0.05720 per kWh, Over 10,000 kWh's used - \$0.05220 per kWh. Also increased the Minimum bill to \$35 per month. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
3. **GS125** - General Service No. 1 – added wording in Type of Service Section. Increased base rate to \$25.00. Added a Demand Charge for First 3 billing kW per month to \$2.00 and anything over 3 Billing kW per month to \$7.50. Increased the Energy Charge – First 5,000 kWh used per month billed at \$0.05720 per kWh. Anything over 5,000 kWh used per month billed at \$0.05220 per kWh. Also increased the Minimum bill to \$35 per month. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
4. **LP026** - Large Power Service - updated the name of Schedule 26 to read Schedule No. LP026, and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
5. **SL027** - Street & Security Lighting - Added Monthly Bill Rate information, removed a section under Conditions For Service, and added 3 sections under Conditions For Service. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
6. **GS228** - General Service No. 2 – Increased Monthly Bill – Base rate to \$30 per month. Updated All kWh to \$0.05810 and increased Demand charge on all kWh to \$8.55. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
7. **TOD27** - Residential Time of Use – On-Peak. Increased the minimum bill to \$35 an updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
8. **TOD28** - Residential Time of Use – Off-Peak – Updated Monthly Bill Base rate to \$27.00 per month, the Off-Peak Energy Charge to \$0.0450 per kWh. Increased the minimum bill to \$35. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
9. **TOD29** - Municipal Culinary & Irrigation Pumping – On-Peak- Increased the monthly bill base rate to \$30.00 per month. Increased the Demand Charge to \$8.70 per kw.

- Updated the On-Peak energy Charge to \$0.07900 per kWh. Increased the monthly minimum bill to \$35.00. Updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
10. **TOD30** - Municipal Culinary & Irrigation Pumping – Off-Peak - Increased the monthly bill base rate to \$30.00 per month. Increased the Demand Charge to \$0 per kw. Updated the Off-Peak energy Charge to \$0.0500 per kWh. Increased the monthly minimum bill to \$35.00.
 11. **GS332** - General Service No. 3 – Increased the Monthly Bill Base rate to \$35 per month. Updated all kWh to \$0.0860. Updated the Demand Charge for all kW to \$9.95. updated the minimum bill to \$35.
 12. **COG33** - Net Metering Service – Residential – Increased the Monthly Bill base rate to \$35 per month and the energy charge per kWh per month to \$0.07180 per kwh.
 13. **COG34** - Net Metering Service – General Service - Increased the Monthly Bill base rate to \$35 per month and the energy charge per kWh per month to \$0.06100 per kwh.
 14. **LP015** - Extra Large Power Service – updated schedule number 15 to LP015.
 15. **SC** - Impact Fees & Services Charges – NO CHANGES
 16. **UT021** - Residential Service – Kanab City – Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT021 will be moved to Utah Schedule RES21 after that date. Increased the monthly Bill base rate to \$22.00. Increased the rate for the first 1,000 kWh's used \$0.07780. Increased the rate for any kWh's used after 1,000 to \$0.07280. Increased the minimum bill to \$35 and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
 17. **UT025** - General Service No. 1 – Kanab City - Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT025 will be moved to Utah Schedule GS125 after that date. Increased the monthly Bill base rate to \$25.00. Updated the Demand Charge for first 3 Billing kW per month to \$2.00 and \$7.50 for any kW's used over 3 Billing kW per month. Increased the rate for the first 5,000 kWh's used \$0.06320. Increased the rate for any kWh's used after 5,000 to \$0.05820. Increased the minimum bill to \$35 and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
 18. **UT027** - Street & Security Lighting – Kanab City (REMOVE)
 19. **UT028** - General Service No. 2 – Kanab City - Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT028 will be moved to Utah Schedule GS228 after that date. Updated the Demand Charge per kW to \$8.55 and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
 20. **UT029** - Municipal Culinary & Irrigation Pumping - Kanab City (On-Peak) - Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT029 will be moved to Utah Schedule TOD29 after that date. Increased the monthly Bill base rate to \$30.00. Increased the Demand Charge to \$8.70 per kW. Increased the On-Peak Energy Charge to \$0.0850 per kwh. Increased the minimum bill to \$35 and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.
 21. **UT030** - Municipal Culinary & Irrigation Pumping - Kanab City (Off-Peak) - Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT030 will be moved to Utah Schedule TOD30 after that date. Increased the monthly Bill base rate to \$30.00. Increased the Demand Charge to \$0 per kW. Increased the Off-Peak Energy Charge to \$0.0560 per kwh. Increased the minimum bill to \$35 and updated the terms of payment to be consistent with all other rates, due and payable within 20 days.

22. **UT032** - General Service No. 3 – Kanab City - Added a paragraph that stipulates that due to a contract ending with Kanab City August of 2016 – Consumer/members within Rate Schedule UT032 will be moved to Utah Schedule GS332 after that date. Updated the Monthly Bill Base Rate to \$35 per month. Updated the Energy Charge per kWh to \$0.092. Updated the Demand Charge per kW to \$9.95.
23. **UTH01** - Residential Service – Hildale - Added a paragraph that stipulates that after AZ rates are approved – this schedule will be updated to equal the Colorado City, AZ residential rate (Schedule ACC01). Increased the Monthly Bill Base rate to \$22 per month. Updated the Energy Charge to \$0.07180 per kWh. Updated the Special Power Adjustment Charge to \$0.02800 per kWh.
24. **UTH05** - General Service No. 1 – Hildale - Added a paragraph that stipulates that after AZ rates are approved – this schedule will be updated to equal the Colorado City, AZ General Service 1 rate (Schedule ACC05). Added a paragraph in Type of Service providing further detail on types of motors used. Increased the Monthly Bill Base rate to \$25 per month. Updated the Energy Charge to \$0.05720 per kWh. Updated the Demand Charge to \$7.50. Added a statement under the Power Factor Adjustment.
25. **UTH06** - General Service No. 1 – Public Bldgs & Authorities – Hildale – Added a paragraph that stipulates that after AZ rates are approved – this schedule will be updated to equal the Colorado City, AZ General Service-Public buildings rate (Schedule ACC06). Increased the Monthly Bill Base rate to \$25 per month. Updated the Energy Charge to \$0.05720 per kWh. Updated the Demand Charge to \$7.50 per kW. Added a sentence under Power Factor Adjustment
26. **UTH08** - General Service No. 2 – Hildale - Added a paragraph that stipulates that after AZ rates are approved – this schedule will be updated to equal the Colorado City, AZ General Service 2 rate (Schedule ACC08). Increased the Monthly Bill Base rate to \$30 per month. Updated the Energy Charge to \$0.05810 per kWh. Updated the Demand Charge to \$8.55 per kW. Added a sentence under Power Factor Adjustment
27. **UTH09** - General Service No. 2 – Public Bldgs & Authorities – Hildale - Added a paragraph that stipulates that after AZ rates are approved – this schedule will be updated to equal the Colorado City, AZ General Service 2-Public bldgs rate (Schedule ACC09). Increased the Monthly Bill Base rate to \$30 per month. Updated the Energy Charge to \$0.05810 per kWh. Updated the Demand Charge to \$8.55 per kW. Added a sentence under Power Factor Adjustment
