On March 24, 2015, the Commission issued a Scheduling Order and Notice of Hearing (“Scheduling Order”) in this docket. The Scheduling Order indicates that the parties were evaluating the ongoing need for a technical conference and agreed to set Tuesday, April 14, 2015, from 1:30 p.m. to 4:00 p.m. (MDT), Fourth Floor Room 401, Heber M. Wells Building, 160 East 300 South, Salt Lake City, Utah, as a placeholder for a potential future technical conference. The Scheduling Order further indicates that the Division of Public Utilities (“Division”) would convey the parties’ desire to hold a technical conference no later than Tuesday, April 7, 2015.

On April 7, 2015, the Division filed a memorandum with the Commission representing that the Division, the Office of Consumer Services and PacifiCorp do not believe the previously referenced technical conference is necessary. The Division further represents that, as of the date of its memorandum, no other party expressed an interest in holding a technical conference. Based on the foregoing, the Commission provides notice that a technical conference will not be held in this docket on April 14, 2015.
