On September 10, 2015, the Division of Public Utilities (“Division”) filed a motion to suspend the remaining schedule and request for stipulation hearing (“Motion”) in this docket. The Motion states the Division’s belief that an executed settlement is imminent and requests that the Commission suspend the remaining schedule dates in this docket and set a stipulation hearing to take place on the date previously scheduled for hearing, Thursday, October 1, 2015 at 9:00 a.m.

The Division represents that the Office of Consumer Services and Rocky Mountain Power support this Motion. The Division also claims that it is authorized to represent that the Utah Association of Energy Users, Utah Industrial Energy Consumers, and Nucor Steel Corporation have been provided notice and do not object to the Motion.

Based on the foregoing, the Commission modifies the March 24, 2015 Scheduling Order and Notice of Hearing and suspends the schedule for filing rebuttal and surrebuttal testimony and will consider a stipulation at the hearing in this docket scheduled for October 1, 2015. In light of the consideration of a stipulation, the Commission vacates the second hearing day previously reserved and noticed for October 2, 2015.
