I do not like legislation that ties our hands. We are a law abiding society. But not all laws are good for the general public. This is one of them.

I urge you to go solar for our future and future generations.

That big bright orb in the sky

Why not use it? It's free.

I did this weird thing the other day when I got conflicting messages about climate change.

I looked into it to verify the discussions for and against the existence of climate change. What is the evidence?

Is it real?

The earth is warming according to records from the last 1000 years.

The earth is not at it's the warmest from records 480,000 years ago (ice core analysis)

Why harp on carbon dioxide (CO₂) when atmospheric water has the greatest greenhouse effect?

This is where it gets complicated. Many get bleary eyed when it comes to the details.

The earth evolved with liquid water. Water is rather miraculous. It basically self-regulates.

If there is too much in the atmosphere, it gets more humid or it rains. The greenhouse effect is needed to make the earth temperature comfortable. 'Runaway' greenhouse effect is what scientists think happened on Venus. All the liquid water evaporated and it is left with permanent CO₂ clouds (96%). The good news is the 'runaway' greenhouse effect, cannot happen on earth. Conditions are not right, but the earth is still subject to warming.

Water is transparent to sunlight. It lets sunlight in (warming), but also lets light out (cooling).

There is a balance to earth's energy.

CO₂ doesn't. It lets sunlight in (warming), but doesn't let light out (no escape of heat).

To balance this effect the earth warms up. It is seen mostly at the poles first.

Climate is localized. Other factors come in to affect local conditions.

Simple to complex climate models all show the earth warming (they all only go to the year 2100).

I don't plan to be around, but maybe our children or grandchildren will.

Why CO₂ not the other gases? They do count, but not as much. CO₂ is tri-atomic like water. Other gases are di-atomic and do not have as much effect.

Complex climate models have taken into account the natural causes of CO₂ in the atmosphere, such as land-use changes, volcanoes, sun variations and fluctuations, aerosols, ocean absorption. The rate of increase in CO₂ in the last 1000 years can only be attributed to the increase in human activity (anthropogenic-created by humans), mainly the industrial revolution and the increased use of fossil fuel. The current rate of increase in world CO₂ levels is unprecedented.

Burning fossil fuels increases the CO₂ in the atmosphere. Burning coal is the worst. To thoroughly burn coal, you want CO₂. CO₂ is not a bi-product. It is the result of complete conversion of burning coal. Burning oil and methane, also cause CO₂, but not as much percentage-wise as coal.

Our earth is powered 83% by fossil fuels (oil, gas, coal). The other 17% is a combination of hydroelectric, biofuels, and alternate energies including nuclear, tidal, geothermal, hydrogen, solar and wind.

Earth's energy balance:

As the world population approaches 7-9 billion, we will need more energy.

Coal is abundant-it won't run out, measured in thousands of years.

Oil and natural gas will run out. It is measured in decades.

Economic GDP (or well being) increase as energy use increases-to a point.

After that there is no measureable increase in GDP (or well-being) inferring that energy is wasted-

this is where conservation comes in. By making what we have and what we do more efficient, our resources will last longer.

What are our resources?

Land, air, water, food, clothing-all required for life

Anthropogenic activities include cars, transportation, manufacturing of equipment and clothing, food production (which by the way uses solar for power to grow plants), landfills use land, but create methane for power and can be reclaimed for houses or solar farms (SLC has done this).

Jobs:

Coal miners (concerns-health, cave-ins, destruction of land)

Transportation (concerns-heavy trucks polluting, spills, noise, road use)

Power plant (delivery, storage, pollution, maintenance, power peaks, facilities, billing control to customers, computers, turbines?, efficient power conversion)

Build power plants

Power Line additions and maintenance (reliable power grid)

Truck fleet maintenance

Feed workers

Benefits-risk factor-health insurance

Building homes-electricians, added power lines

All the above will still be required, except the coal extraction and associated pollution and activities will be replaced by clean alternate energy such as wind and solar.

Houses will still need to be built (though they could be more efficient-not necessary with solar power), PV panels and wind turbines will need to be manufactured.

They will still have to be delivered and installed.

The grid will still need to be maintained. Insurance cost should go down for a less risky profession.

Many similar and new jobs will be created. It won't happen overnight so old polluting jobs will slowly become obsolete and eliminated by attrition.

Will the sun burn out?

The sun is estimated to be 4.5 billion years old. It has been calculated to shine for another 5 billion years. It will turn into giant red dwarf and encompass Venus and maybe even earth. I don't think I'll be around. All life on this planet will be destroyed, not just humans. This is part of the recycling of chemical in our universe. Let's not poison ourselves before then

2-Fl and environment-800 ppm-scientist predict permanent damage after double current CO2 levels-280 ppm?

3-No Fl and environment-560 ppm still high, but maybe manageable for life

4-No Fl and economics-580 ppm-still high but may be able to keep our quality of life.

I've read about the wedge approach, which selects seven of the many ways to reduce CO2 emissions .

We have to start sometime, it might as well be now before it is too late and our options are limited or forced upon us.

I realize this is lengthy but it is a summary. Actual literature is much more complex and goes deeper into the cause and effect of global climate change.
