Petitioner now comes before the Public Service Commission (PUC) of Utah in regards to a Final Response to Docket #'s 15-035-19 & 15-049-04 in regards to a Formal Complaint against Rocky Mountain Power Company and Century Link.

Petitioner per a document filed on April 16<sup>th</sup> has stated Petitioners Complaints and this time feels that due to the fact that a SLC Department of Transportation permit was never obtained admitted by Eric Holje of RMP, that the Complaint against RMP is warranted and should be documented, with an Order from the PUC instructing RMP to follow all protocol with all permits in the future before their works begin, continue or expand etc...

\*SLC Corp. does not request Utility Companies to obtain permitting like the IRS does not request taxpayers to pay their taxes; entities do this or suffer consequences.

Petitioner would request the PUC to place Century Link on Order of Advisement that it would be that they had/have or will have proprietary knowledge and product involved within the works at Grace Court and that this particular situation should be addressed properly with all correct permitting and protocols followed accordingly.

Petitioner again reflects to the PUC that personal losses of not being able to use Petitioner's property at will, which denied the ability to use Public Utilities at will, have been extremely hard to precisely calculate; in that Petitioner was not legally, lawfully or in regards to liability issues able to use the solutions offered.

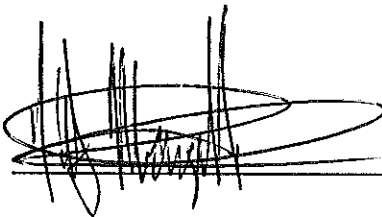
