The Application shall be deemed approved by the Commission, effective **Thursday, June 18, 2015**, unless a person affected by the application submits a request to the Commission in writing no later than **5:00 p.m. (MDT) June 17, 2015**, that the Commission hold a public hearing or provide additional time for the person to investigate the application.
