Pursuant to Utah Code Ann. § 63G-4-201, 203 and Utah Admin. Code R746-100-3, Rocky Mountain Power (the “Company”) respectfully requests that the Public Service Commission of Utah (“Commission”) approve its agreement with Levan, Utah (“City”) whereby the Company agrees to allow the City to provide electric service to certain customers (“Additional Customer(s)”) outside its municipal boundary (“Agreement”). The Agreement is attached hereto as Attachment 1. Attachment 1 includes a Confidential Appendix 1, which contains proprietary customer information. In support of this petition, the Company states as follows:

1. Rocky Mountain Power is a public utility in the state of Utah and is authorized by a certificate of public convenience and necessity issued by the Public Service Commission of Utah (“Commission”) to provide electric service to customers in areas outside the municipal boundary

of the Municipality. Company consents to City providing electric service to certain Additional Customer(s) – identified more particularly in Attachment 1 – outside of the municipal boundary.

Rocky Mountain Power's principal place of business in Utah is 201 South Main Street, Suite 2400, Salt Lake City, UT 84111.

2. City is a municipal provider of retail electric service within the municipal boundaries of the City. ~~City consents to the Company providing electric service to certain Additional Customer(s) – identified more particularly in Attachment 1 – within its municipal boundary.~~ The municipal offices of ~~Levan-Lehi~~ City are located at 20 N. Main, P.O. Box 40, Levan, Utah 84639-153 North 100 East, Lehi, Utah 84043.

3. The Legislature of the State of Utah passed Senate Bill 180 (the “Bill”) during the 2013 General Session of the Legislature amending Utah Code Ann. § 10-8-14 and thereby allowing a municipal utility to continue providing service to customer outside its municipal boundaries if the municipality meets certain requirements provided in the Bill. The Bill became law on May 13, 2013.

4. Pursuant to Utah Code Ann. § 10-8-14 the City has submitted a request to the ~~Company-City~~ to provide electric service to ~~the~~ certain customers outside of the municipal boundary. The Company has agreed to allow the City to provide electric service to the Additional Customer(s), and the City and the Company have entered into such an Agreement in compliance with Utah Code Ann. § 10-8-14 and 54-4-40 and subject to the approval of the Public Service Commission. A map showing the approximate location of the Additional Customer(s) is attached hereto as Attachment 2.


