In its Scheduling Order, Directive to Stipulate to Date for Technical Conference and Notices of Hearing and Public Witness Hearing issued January 12, 2016, the Commission directed the parties to stipulate to a date for a technical conference and file such stipulation with the Commission on or before January 25, 2016. The parties requested the Commission issue this direction at the Scheduling Conference on January 6, 2016.

On Thursday, January 21, 2016, the Commission received a phone call from the Division of Public Utilities' counsel Patricia Schmid, informing the Commission the parties had stipulated that a technical conference be held on February 9, 2016 at 9:00 a.m. (MST). The Commission understands the purpose of the technical conference is to allow Rocky Mountain Power to present information to Commission staff and interested parties concerning its application in this docket.

The Commission notes Rocky Mountain Power has designated a significant amount of the material it submitted with its application as confidential. The Commission anticipates one or more parties may desire to close all or a portion of the conference to the public or to take other measures necessary to preserve the confidentiality of this information during the conference. The parties may file statements of their position on this issue, jointly or otherwise, in advance of the conference. At a minimum, any party who desires to close all or a portion of the technical conference should come to the conference prepared to discuss whether doing so is appropriate under Utah Code Ann § 54-3-21.

Individuals wishing to participate by telephone should contact the Commission two days in advance by calling (801) 530-6716 or (toll-free) 1-866-PSC-UTAH (1-866-772-8824). Participants attending by telephone should then call the Commission at one of the numbers posted above five minutes before the conference to ensure participation.
